

MAHA SHAKTI RETREATS

TERMS & CONDITIONS

By booking and paying for a Maha Shakti Retreats event, you confirm that you have read, understood and agreed to these Terms & Conditions.

1. Booking & Deposit

A €500 deposit is required to secure your place at the retreat. The deposit is applied toward the total retreat price and allows Maha Shakti Retreats to secure accommodation, activities, transportation and other retreat arrangements in advance.

The €500 deposit is non-refundable and non-transferable and cannot be exchanged for cash. However, if you are unable to attend the retreat, the deposit may be transferred as credit toward a future Maha Shakti Retreats retreat, subject to availability and any applicable terms of the new retreat. The transfer must be requested within 12 months from the original retreat start date. The credit may be applied toward any Maha Shakti Retreats retreat available within this 12-month period.

2. Remaining Balance

The remaining balance must be paid no later than 14 days before the retreat start date.

Failure to pay the remaining balance by the deadline may result in cancellation of your booking, and the €500 deposit will remain non-refundable and may only be transferred to a future Maha Shakti Retreats retreat in accordance with Section 1.

3. Cancellation & Refunds

If you cancel your participation for any reason, the €500 deposit is non-refundable, but may be transferred as credit toward a future Maha Shakti Retreats retreat, subject to availability.

Any remaining balance already paid is non-refundable if you cancel your participation.

No refund or reimbursement will be provided due to illness, injury, change of plans, travel difficulties, visa issues, flight delays or cancellations, personal circumstances or any other reason preventing participation, except where required by applicable law.

Participants are strongly advised to purchase appropriate travel insurance, including cancellation and trip-interruption coverage.

4. Transfer of Booking

A booking may not be sold or transferred to another person without the prior written approval of Maha Shakti Retreats.

Any approved transfer must comply with the applicable booking requirements and conditions set by Maha Shakti Retreats.

5. Cancellation by Maha Shakti Retreats

If Maha Shakti Retreats cancels the retreat, all amounts paid by the participant toward that retreat, including the €500 deposit and any remaining balance, will be fully refunded.

Alternatively, where offered and agreed by the participant, the participant may choose to transfer the full amount paid toward another Maha Shakti Retreats event, subject to availability.

6. Travel Arrangements

Flights, visas, travel insurance and other personal travel expenses are not included in the retreat price unless expressly stated otherwise.

Participants are responsible for arranging their own travel, obtaining the necessary travel documents and purchasing appropriate travel insurance.

Maha Shakti Retreats is not responsible for losses arising from flight delays, cancellations, missed connections, visa issues or other personal travel arrangements outside its control.

7. Health, Safety & Participation

Retreat activities may include yoga, breathwork, dance, movement, excursions and other physical activities that carry inherent risks, including injury or illness.

Participants are responsible for participating within their own physical limits and following reasonable safety instructions.

Participants must inform Maha Shakti Retreats of any relevant health conditions, allergies, medications or dietary requirements that may affect their participation.

Participation is voluntary, and participants accept the inherent risks of the activities, to the extent permitted by applicable law.

Maha Shakti Retreats may ask a participant to modify or stop an activity, or leave the retreat, if their participation creates a reasonable safety concern or seriously disrupts the retreat.

8. Participant Responsibility & Liability

Participants are responsible for their own health, safety and personal belongings during the retreat.

To the fullest extent permitted by applicable law, participants agree not to hold Maha Shakti Retreats, its organisers, instructors, staff, partners or activity providers responsible for injury, illness, loss or damage arising from participation in retreat activities, except where such liability cannot legally be excluded or limited.

9. Behaviour

Participants are expected to behave respectfully toward other participants, staff, instructors, accommodation providers and activity providers.

Maha Shakti Retreats reserves the right to take appropriate action, including asking a participant to leave, where their behaviour is unsafe, abusive, seriously disruptive or materially violates these Terms & Conditions.

10. Dietary Requirements

Participants must communicate any dietary requirements or food allergies before the retreat.

Maha Shakti Retreats will make reasonable efforts to accommodate dietary requirements communicated in advance but cannot guarantee that meals prepared by third-party providers will be completely free from allergens or cross-contamination.

11. Acceptance

By completing your registration and payment, you confirm that you have read, understood and agreed to these Maha Shakti Retreats Terms & Conditions, including the booking, payment, cancellation, health and safety, liability and participant responsibility provisions.

Nothing in these Terms & Conditions excludes or limits any rights or protections that cannot legally be excluded or limited under applicable law.
